Wallace discovered his passion for active school travel in 2007 as a parent volunteer directing bell-time traffic at his children's school.

In 2009 he joined <u>Green Communities Canada</u> (GCC) as the first School Travel Planning Facilitator in Ottawa, growing a small pilot project into one of the largest, self-sustaining programs of its kind in Ontario. As GCC's Active & Safe Routes to School (ASRTS) Program Manager for Ottawa he conceived and launched an innovative Walking School Bus pilot, helped create the Ottawa School Active Transportation Network and was recognized by the City of Ottawa and the Ottawa Safety Council for his commitment to safe, sustainable school travel. In October 2017 Wallace and the ASRTS program migrated to Ottawa-based <u>EnviroCentre</u>, a local organization with a strong track record in promoting sustainable transportation options. He remains an advisor to GCC on its new Ontario Active School Travel Program.

Wallace is a graduate of Queen's University, Université Laval, and Algonquin College, and is completing the Next Generation Transportation certificate program at Simon Fraser University.
